Format & Rules of the session

1. WHAT

In order to stimulate open discussions and a highly interactive audience, the panel will be constituted by two moderators and one introductory speaker only. The introductory speaker, an experienced practitioner and expert in the respective subject matter, will introduce the topic by giving a short thought provoking keynote. Subsequently, the floor is opened to thoughts, suggestions and questions from the floor. Audience members can present their views, other members can respond, while the interactive and lively discussion is led by two experienced subject matter dispute moderators.

2. HOW

In order to have a meaningful discussion as suggested above, the 2023 NAI AGM delegates will be contacted in the weeks leading up to 14 September 2023 to submit their views, questions and thoughts. The topics of the two panel sessions mentioned are (i) Energy Disputes and Arbitration and (ii) Post M&A Disputes and Arbitration.
