Subject: File naming convention for the NAI arbitration platform

1 INTRODUCTION

- On the NAI arbitration platform, users can access all case files. It is important that parties agree
 with the arbitral tribunal on how files will be uploaded and to decide on a naming convention to be
 used. This ensures that files are easy to find, files can be sorted easily and that it is immediately
 clear what the file is about.
- 2. The NAI has drawn up these guidelines to help parties, representatives and arbitrators to keep the case files in order. Of course, the parties and the arbitral tribunal may agree to use a different naming convention.

2.1 Correspondence

- 3. Correspondence by letter is uploaded in a searchable PDF. The file name format is as follows:
 - [yearmonthday sending party-receiving party subject of the letter (NAI [Case number])]
- 4. Some examples:
 - 20230105 NAI-Respondent Request for Arbitration for and request to submit Short Answer (NAI 1234)
 - 20230119 Respondent-NAI Request for postponement of submission of Short Answer (NAI 1234)
 - 20230220 Tribunal-Parties Date of Case Management Conference (NAI 1234)

2.2.1 Submissions

- 5. Submissions are uploaded in a searchable PDF with an overview of the exhibits. The file name format is as follows:
 - [yearmonthday name of the procedural document (NAI [Case number])]

 - [(exhibit number: where the Claimant puts an C in front of the number and the Respondent R) yearmonthday of the document subject of the document (NAI [Case number])]

 - C-001 20190104 shareholders' agreement between parties X and Y (NAI 1234)
 - C-002 20220612 email Mr X to Ms Y about a tie (NAI 1234)
